## **Congregational Covenant of Right Relations**

We commit to living and working with this covenant, revisiting it as needed. In this spirit, we covenant as follows:

- To foster hospitality, extending a warm welcome to all our members, friends and visitors, and work intentionally to insure that here no one is a stranger.
- To foster a community that embraces diversity in all of its manifestations within a safe, positive, and nurturing environment.
- To move beyond simple tolerance toward genuine understanding. To recognize that all people are free to make choices regarding their own personal and spiritual journeys.
- To listen attentively, seek others' opinions, and understand that differing values do exist within our religious community.
- To deal with disagreements constructively, communicating with others in a direct, caring, and responsible manner.
- To recognize that youth are an integral part of our community and welcome them in all facets of church life.
- To express gratitude and support to the staff, church members and friends who volunteer their time and talents in support of the programs and governance activities of the church.

Although this document expresses our written promise, our true covenant exists in our actions. In times of harmony, may it deepen our bonds with one another and in times of conflict, may it guide us in working through our differences.

176<sup>th</sup> Annual Meeting Minutes  
Sunday, June 2, 2013

Present: Board of Trustee Members: Rob Neimeier, Harsey Leonard, Felicia Otero, Jennifer Newman, Gary Droege, Jason Winkler, and Joan Weiser. Treasurer: Joyce Leonard and 57 voting members of the society.

Chalice Lighting and Opening Words: Jean Wahlstrom

Call to Order: 7:02 pm: Harsey Leonard, President, May Memorial Unitarian Universalist Society. Move to adopt the agenda by Randy Archambault, seconded by Ken Pease, all in favor. Vote was affirmed by a show of hands; all in favor and no opposed. The agenda was adopted as presented.

The Chairman called for adoption of the minutes of the June 2, 2013 Annual Meeting. Move to adopt last year's minutes as presented. Moved by Stephanie Cross, seconded by Don MacKay, affirmed unanimously.

The President called for a motion to approve the minutes of the April 14, 2013 Congregational Meeting. Alice Chico moved to approve the minutes of the April 14, 2013 Congregational Meeting, seconded by Joan Loveridge-Sanbonmatsu. Vote was affirmed by a show of hands.

Folkus Project: The President introduced Dana Cooke, representing the FOLKUS Project: Dana, on behalf of FOLKUS, expressed gratitude again to MMUUS for use of the building, and MMUUS' support for their programs. Dana announced there would be a check for approximately \$1700 for concessions for the year, and a second donation for \$1000 towards the capital campaign.

Annual Reports: The President called our attention to the annual reports of the Society's standing committees presented in written form and published in the annual report. They are available for members' examination.

The President called for any new business. No new business was introduced.

Presentation of Operating Budget for 2013-2014: Joyce Leonard, Treasurer pro tem, introduced the Operating Budget for 2013-2014. Joyce has been treasurer pro tem for almost two years, and asked for names of anyone who might be interested in the finance committee and/or someone looking to be treasurer. This is the 4<sup>th</sup> year of a balanced budget. There is a projected year-end surplus of \$966. She identified the moving of investment income into the draft budget. She mentioned that health insurance premiums go up every year. She called our attention to the on-line accounting cost, and to significant savings in physical facilities' expenses due to reduced bids for lawn care and snow removal, reduced cleaning costs, and trash removal cost reductions. Utilities continue to improve with the new roof. If the capital budget is approved, 10 new furnaces will result in additional savings. Money set aside in the prior year in anticipation of this year's sabbatical expenses made it possible to balance the budget. If we had paid Fair Share this year, the total amount would be \$11,640. Joyce encouraged the congregation to work on becoming a fair share congregation again in the near future. Joyce called for comments or questions on the budget, there were none, and the question was called. Joan Loveridge-Sanbonmatsu moved to adopt the budget as presented; Vicky Schipper seconded; the budget was adopted.

Recap of Capital and Endowment Fund Investments: April and May were very good months.

Capital Campaign: Harsey talked about capital spending thus far. Completed projects include a new roof and new computers. The contract has been signed for the replacement of furnaces, new pew cushions are in the works, and we have budgeted for a new sound system and new furniture for the religious education program. The costs of repaving the front drive were still being pinned down. The first year Capital Campaign spending will amount to \$137,687. There was a motion to adopt the capital budget as presented; so moved by Ken Pease, and seconded by George Adams.

Election of Officers, Trustees, and Nominating Committee: Linda Wobus from the nominating committee presented the slate of officers for the coming year. The Chairman called for nominations from the floor. There being none the Chairman called for a motion to adopt the slate as presented.

Joan Loveridge-Sanbonmatsu moved to nominate the slate by acclamation, seconded by Beverly Adams, slate approved unanimously. The following were duly elected:

## President's Letter

Your Board has met 15 times in the last year. I want to thank our Board members for their time and their thoughtful consideration of the various board agenda items. I was unable to attend one meeting, but Rob Neimeier took over for that: special thanks, Rob.

Joan Weiser's term as a trustee is expiring. I will miss her "cut to the chase" questioning in Board discussions. Jennifer Newman has been the Secretary for three years now. She is not running for a fourth year as Secretary. I will miss not only her conscientious work on minutes of our meetings but also her unique perspective on the matters which come before the Board. Special thanks to Joan and Jennifer.

I attended both UULTI (Unitarian Universalist Leadership Training Institute) and the recent District Assembly in Erie, PA. Pilar Lyons also attended UULTI. Gary and Alexa Carter plus Richard and Sherri Coombs also attended this District Assembly. It is worth attending these events both for the actual programs and for the opportunity to meet other UUs. We tend to think of ourselves as a small, a minority denomination. By coming together at these programs, we become aware that we really are not all alone, not as small as we think we are. Some of the congregations are growing and others are struggling, but we all have many things in common. Nationwide most religious denominations are decreasing in membership, but hold your head up: while the membership numbers for the evangelicals are in decline, membership in UU churches as a whole is not dropping.

This coming year, UULTI is going to have a different format. There will not be a three or four day conference. Instead there will be a combination of webinars and small-region one-day meetings. We will be able to send folks and professional staff to one-day meetings in Binghamton. The thinking seems to be that this way churches can send more people for training, and that that will cause the training to be more successfully used back at churches like ours. Do we need the training? Well, when we left Binghamton in 1979, that church was quite small but now it is much larger and more prosperous than ours. I'd say we can use all the help we can get.

Some of you may want to attend this year's General Assembly. It is held in different locations each year. This year it is really close, in Providence, Rhode Island. While you are there you might want to try some fresh lobster. For more info, just go to the UU ULTIA website.

This year the unique situations we encountered included granting Rev. Jennifer Hamlin-Navias's request for 6 months leave for family reasons. We arranged for Kelly Sphar to fill in for her in performing RE leadership duties. Stephanie Sherman-Cross, our RE chair, also played a major part in successfully filling in for Rev. Jennifer.

This made hash of Rev. Jean Wahlstrom's sabbatical plans because she did not want to be gone at the same time as Rev. Jennifer. Jean, thank you for being so conscientious.

Another situation has arisen: although we will miss her, we are certainly happy for Rev. Jennifer that she now will be the parish minister of a sister UU church. She deserves our heartfelt congratulations on obtaining this position. Meanwhile we are working to locate someone new to direct our religious education program. The Board appointed a search committee and has full confidence that they will locate some highly qualified candidates for the Board to consider. Here's the committee membership: Stephanie Sherman-Cross, Rob Neimeier, Stacy Sceiford, Jasmine Pitzrick, and Richard Coombs. They are a great team. Rev. Jennifer is leaving our RE program in good shape so that we will seamlessly continue our tradition of operating a high-quality religious education program.

This Easter Sunday we brought in a special presenter, Matt Meyer. Pilar Lyons and I had met Matt at last August's UULTI and had been impressed with his unique blend of talents. The feedback I've heard has mostly been quite favorable.

On May 11, we had another joyful occasion: the formal ordination of Kelly Spahr, now known as Reverend Kelly Spahr. It was well-attended even though the weather was fine, a reflection of the place Kelly has in our hearts.

If you have carefully read the Treasurer's report you will understand that we are living within our 2013-2014 budget, although this is in no small part due to money not spent on salary for Rev. Jennifer during her unpaid 6 month leave of absence. Because of a significant difference between pledges made and actual pledge income, we would have had a major deficit if she had not taken the leave of absence, although we did not anticipate this deficit when we granted her leave request.

An important part of our budget is special fundraisers. This year we had another highly successful Holiday Craft Fair. This involved very hard work, and the hardest worker of all was Janet Hiemstra.

We also had a great Goods And Services Auction. Here I single out Lynne Perry and Alexa Carter, but there were many others who helped make this a success.

Thanks too to all who helped make the First Sunday Lunches such a financial and fellowship success.

The capital fund's energy improvements (insulated roof and new furnaces) have cut our energy usage more than projected, even with our unusually cool winter. This has helped us handle the large and unexpected utility rate increases.

This year's canvas was expertly run by Steve Reiter and Lynne Perry. It would be great if they would do it again. Given that some members have moved away and a few others have died, Steve and Lynne did an excellent job. They helped people understand that May Memorial is changing lives. This message is probably why there were widespread pledge increases. Even so, it is also true that this year's pledge total is slightly lower than last year's.

We do have some problems. For example, as of the congregational budget hearing, we do not have a treasurer after June 1. Please contact me if you would like to be considered for the position. We do not have a working social justice committee although there still are concerned members of the congregation who do still carry on past social justice practices. We have a membership committee but it is operating without a chair. Green Sanctuary and Memorial Garden committees are low on members. Summer is coming, but some of us are already working on plans for the upcoming year, to make it more HUGE. We have been joined by some wonderful new members, and if you haven't met any of them yet, you are missing out. By August, you'll want to make checking our website a habit. Big changes are coming there by then. By fall, the kitchen will be redone to make it much more functional. The current stove will be hauled away in Gary Carter's trailer. The future is full of challenges and opportunities.

## **Building & Grounds Committee**

The following are some of the highlights of the Building & Grounds Committee's accomplishments over the last year:

- A provision was made to remove a number of trees this past year including one very large poplar, one box elder and two hawthorns, which were a source of safety concerns for the Growing Place.
- We broke ground on the Capital Campaign program projects, especially the installation of the new furnaces.
- A major re-ballasting of the light fixtures was undertaken, as well as the replacement of T12 bulbs into T8 bulbs, for energy saving purposes. Five new ceiling lights were installed in the corridors and two light globes were added to the foyer.
- Vacuum breakers were replaced in the first floor women's restroom and in room 1 of the RE Program space.
- Two new diaper changing tables have been installed in the first floor men's and women's restrooms.
- The Building & Grounds Committee co-hosted one of the Sunday luncheons with the Green Sanctuary Committee.
- Preparation is underway to clean the Sanctuary windows and to replace the cupola lights with a new LED light.
- The Building & Grounds Committee adopted a new work request system.

I want to thank all the committee members and friends who have graciously offered their time and expertise to keep our building and grounds in decent shape, especially Bruce Macbeth, Erwin Reiner, Bob Rohde, Charlie Hannah, Remo Bianco, Dale Sherman, Mariah Dillon and Ralph Mietz. And a special thank you to Peter Colman, who has been most willing to assist and share his knowledge and experience during this year of transition.

**Committee on Ministries**

The Committee on Ministries acts primarily as a counsel to the Parish Minister, the Associate Minister for Religious Education, as well as being a resource for the Board of Trustees, other committees and the entire congregation regarding all aspects of our shared ministry. More information about our charge can be found in the operating manual. We receive our charge annually from the Board of Directors.

At the end of last year, this committee, joined by representatives of the Worship Committee and Board of Trustees, worked to support Reverend Jean's sabbatical plans. In August 2013, we met again to restructure those plans when Rev. Jennifer requested a leave of absence because of her father's severe illness.

In April, the Board of Trustees again charged us with doing a Congregational Health Assessment, using the same tool that we used in 2010. We again asked the following questions:

- 1) *What is MMUUS doing well, and how is this helping you realize our shared mission and vision?*
- 2) *How might we do this better?*

As of this writing (May 11, 2014), about a dozen people have shared their concerns with us. All the responses which are received by May 23, 2014 will be reviewed and shared with the Board, and ultimately with the staff. Of course, requests for confidentiality will be respected.

## Green Sanctuary Committee

Kénel Antoine resigned as committee co-chair, and Lynne Perry was chosen to replace him.

Members of the committee read *The Green Boat* by clinical psychologist Mary Pipher. The book speaks of how the majority of Americans believe in global warming, but feel overwhelmed by what is happening and unsure of what they can do personally to make a difference. She gives an example of how she and fellow Nebraska activists protested the Keystone Pipeline. Following their readings, Green Sanctuary members tabled in the Social Hall, offering to loan one of its copies to interested church members. The formation of a group to meet and discuss the book is being pursued.

A review was undertaken of the company that cleans the church and the type of supplies being used. A discussion was held about changing to another company, which uses only green cleaning supplies. However, the committee ended up being satisfied with the current company and voted to retain it.

Planning is underway for a symposium in September entitled *Awakening the Dreamer*, which will educate attendees about the challenges and possibilities that we currently face. The meeting will be held at May Memorial and presented by *The Pachamama Alliance*, a non-profit organization that empowers indigenous people of the Amazon rainforest to preserve their land and culture and to inspire all people to work towards a just and sustainable world.

The Green Sanctuary Committee is responsible for the July 27<sup>th</sup> service, and will present a skit featuring Mother Earth, as the judge of both those who contribute to the crisis of climate change and of those who work to understand its causes and strive to aid in the planet's recovery.

Committee members have lobbied senators and representatives to recommend that they vote against bills that would contribute to climate change and vote for those that would aid in controlling its rapid increase.

### **Campaign Summary**

This year's campaign was co-chaired by Lynne Perry and Steve Reiter. The campaign had the theme "Another 50 Years of Changing Lives."

Our goal was to raise \$257,758 in pledges. This amount would have fully supported our Society in the coming fiscal year, including paying our Fair Share for the national and regional UU services we receive, as well as cost of living raises for our staff.

It was an ambitious goal, given that in the prior year we only received \$196,448 in pledges (some of which are not expected to be fulfilled) and an additional \$8,947 in non-pledge contributions received over the year, for a total of \$201,075.

As of this date, the campaign has raised \$207,295 in pledges, which is \$6,220 more than last year's campaign raised.

There were 183 potential donors (formerly called pledge units) on the list generated by Malcolm Clark and Steve Reiter. Compared to last year's pledges, 92 pledged the same, 60 went up, and 31 went down. Pledges were also received from two donors who recently started attending here.

### **The Process**

The committee co-chairs were recruited in December of 2013, and met for the first time in January, along with a number of previous Stewardship Campaign chairs and others with historical longevity. Given the late start and lack of sufficient time to organize a kick-off celebration, it was decided that the campaign would formally be initiated in the Sunday service on March 9<sup>th</sup>, with a sermon focused on giving and an appeal for paying one's fair share by the committee co-chairs.

The Board of Trustees was approached in February to gather their donations prior to the kickoff of the campaign.

The co-chairs recruited nine members, who, along with the co-chairs, agreed to reach out to donors who had yet to submit a pledge for the coming year. These individuals include: Remo Bianco, Larissa Brenner, Alexa Carter, Alice Chico, Peter Colman, Harsey Leonard, Don MacKay, Rob Neimeier, and Vicky Schipper. Their help made our work a lot easier. They, along with the co-chairs, reached out by phone (and, in some cases, email) to every member and friend who had made a pledge the previous year or made a donation of record in the prior calendar year and who had not already submitted their pledge.

As in recent years, we decided not to make the effort of having personal visits for everyone. However, the option to arrange a personal visit was available to the caller, should it seem like

a face-to-face conversation was wanted or would be more appropriate. To our knowledge, no visits were made.

As expected, many of these donors submitted their pledges prior to being called. Consequently, far fewer phone calls were required. Many donors received more than one phone call (and sometimes emails, as well), as the campaign drew on and they had yet to submit a pledge.

Thank you cards were sent out to all those who pledged. The cards had a pre-printed message of thanks from the Board of Trustees and the Campaign chairs, and was signed and mailed, along with a brief message of appreciation, by one of our volunteers. This was always the caller, if a call was made.

The top 30 donors in last year's campaign received thank you cards with a personal message of appreciation from Peter Colman, our Board President.
